Presenter 4: Jaqueline Murdocco, Treasurer:

- Susanne Rice:
 - O Current bank balance: \$18,207.54
 - 2 of the grants from last year had not been cashed.
 - Reissued Checks Total \$900
 - o Found \$500 in sponsorship missing now paid
 - Refund \$100 to a sponsor that paid twice by accident.
 - Fashion Show
 - \circ \$8985 ticket sales
 - Paid for 150 tickets our of organization
 - We only had 147 attendees
 - We paid a lot in fees for Eventbrite ~\$800.00
 - Liangy suggested looking into Wix event platform.
 - O Make an incentive for cash buyers who pay in advance.

- O Raffle raised \$280
- Silent Auction raised \$4k
- o Sponsors \$8200
- O Total = \$33,270 Revenue (Birthday fundraisers, directory ads)
- o \$22,770 was Fashion Show Revenue
- o \$320 raised by centerpieces.
- \$10,865 expenses from fashion show
- o \$11,904 profit from fashion show.
- \$14,000 proposed allocation for grants and scholarships:
 - \$11,000 for grants (\$550 per recipient if 20 grants awarded)
 - **\$3,000** for scholarships (3 at \$1,000 or 6 at \$500)
- Susanne mentioned that she want to operate at 30% and give 70%
- Kendra made motion to form a committee to evaluate criteria and process and number and amount for grants and scholarships.
- Jacqui seconded
- Motion passed.
- Delineate what it is that Liangy does and has a job description attached. Liangy has not been paid for the bonus.
- Liangy needs to be issued a 1099.
